WPL Auction 2023: Australia all-rounder Ashleigh Gardner leaves behind Harmanpreet Kaur to fetch INR 3.2 crore

New Delhi. Australia all-rounder Ashleigh Gardner fetched INR 3.2 crore in the inaugural edition of the Women's Premier League (WPL) on Monday, February 13.

Gardner had a base price of INR 50 lakh and came up in the auction in the first set. Mumbai Indians started the bidding war, after which UP Warriors and Gujarat Giants joined in. The two teams engaged in a bidding war for quite some time before Gaujarat roped her in.Gardner came into the auction after bagging the Player of the Match award against New Zealand in the Women's T20 World Cup match against



New Zealand at Boland Park in Paarl. She registered the third-best figure in the history of the women's mega event,

- Gardner also broke Adam Zampa's record of the best bowling figures by an Australian in all T20 World Cups. In the first set, Gardner became the second-most expensive player after Smriti Mandhana, who went to the Bangalore-based franchise. The 25-yearold Gardner fetches a higher price than Indian skipper Harmanpreet Kaur, who fetched INR 1.80 crore from Mumbai.
- Apart from Gardener, Australian all-rounder Ellyse Perry also set the auction on fire. She went to the Royal Challengers Bangalore (RCB) at a price of INR 1.70 crore. The Challengers entered into a bidding war with the Delhi Capitals before bagging her.
- Perry has been a key all-rounder for the Aussies and recently became their only player to score 1500 plus runs in T20Is along with more than 100 wickets. In women's cricket, only Pakistan's Nida Dar and New Zealand's Sophie Devine have the record to their name.


